CONSENT

For All Skin and Facial Needling Patients:

I _____ request the needling procedure application. This process can plump up the skin resulting in softer smoother looking skin, more All needling procedures usually require multiple sessions. Final results cannot be determined until all follow-up applications are completed. You may see results for 6+ months or longer. We cannot guarantee results.

It is imperative that you follow all after care instructions provided to you at consultation time and after each application touch-up.

Fee for needling is \$250.00 per 30 minutes. For some cases, fees may be charged by the centimeter.

Procedure fees are payable as each treatment is provided. We will not bill your insurance company. (There are no exceptions!)

There is no charge for a 15-minute consultation, however, there is a \$50.00 + fee for 16-30 minutes, 31-45 minutes is a \$100.00 fee.

Sensitivity tests may be performed at your consultation visit. There is a \$50.00 fee for this service.

Follow This Regimen of Daily Care Until Healed:

1. Clean with Witch Hazel the following day of your procedure using a cotton ball, continue use morning and evening before applying Vaseline or A+D type.
2. Do not touch the treated area unless applying ointment with a Q-tip.
3. Apply ointment 2-3 times a day using Q-tip to keep area moist. However, if you experience stinging or itching, the skin may be too dry and more ointment can be applied.
4. You can let the shower run over your face when ointment is applied
5. Do this for 3-4 days until healed.

I fully understand, as with all such procedures that this is not a science but rather an art that anything that can go wrong may go wrong. I request the needling procedure appreciating and accepting the temporary effects or permanency of the procedure as well as the possible complications and consequences of said procedure(s). x_____Date

CUSTOMER HEALTH HISTORY

To avoid unforeseen complications, please answer the following questions. Answering "yes" to any of these questions does not necessarily preclude you from receiving permanent make-up. However, be sure to call ahead to discuss any Yes answers with Operator no less than one week before permanent makeup is applied.

- Yes No Are you pregnant? Permanent makeup cannot be administered if you are pregnant without written consent from your obstetrician.
- Yes No Are you allergic to any of the Caine family of drugs (ex., Novacaine for dental work)?
- Yes No Do you have problems numbing and remaining numb at the dentist with Novacaine?
- Yes No Are you sensitive to Latex? I do have synthetic gloves if Latex gloves are a problem.
- Yes No Have you ever had a reaction to products with a petrolatum base? I use Aquaphor ointment.
- Yes No Do you have oily skin? Excessive oily skin can cause premature fading of a tattoo.
- Yes No Do you have any conditions that might affect the healing process? (example: Are you slow to heal?)
- Yes No Do you have Lupus or any skin disorder that is not visible? If so, healing can be hampered.
- Yes No Do you have any conditions that cause excessive bleeding? Do you have problems stopping bleeding with a cut or scratch?
- Yes No Have you had previous problems with your tattoos? It is important to share what happened with Operator.
- Yes No Are you currently undergoing radiation therapy? If so, Physician must provide written consent.
- Yes No Are you currently using Alpha Hydroxy, Retin-A or Glycolic skin care products? These will cause premature fading of tattoos.
- Yes No Have you applied eyelash enhancing serum to your eyelashes in the last 6 months?
- Yes No Have you had any alcohol within the last 16 hours? No alcohol 16 hours before procedures.
- Yes No Have you had any illegal mood altering drugs in the last 16 hours?
- Yes No Have you consumed any anticoagulant pain relievers (Aspirin, Excedrin, Ibuprofen, Aleve, Advil, Naproxen, etc.) in the last 48 hours? Tylenol is okay.
- Yes No Have you consumed any anticoagulant supplements (Vitamin E, Fish Oil, Flaxseed Oil, Ginko, Garlic, etc.) in the last week (must be off these one week prior to procedure)?
- Yes No Have you been jaundice (yellowing of skin or eyes) in the previous 10 days?
- Yes No Do you have any medical conditions that would require a physicians consent to have a tattoo?
- Yes No Have you had Botox, or facial fillers in the past 4-6 months contact me to prior to your scheduled procedure, depending on your brow line we may need to reschedule.

The OPERATOR makes no attempt to, or claim to practice medicine. Some individuals will have complications related to permanent make-up application. These complications are usually mild and last only a few days, however, extreme complications are always a possibility. Ultimately, if you are healthy, the decision to have or not to have a tattoo is up to you. If you are healthy and there are no visible reasons restricting you from receiving a tattoo, you must approve of the design and color selection before OPERATOR will apply your permanent make-up.

Before and After Care Instructions

'Skin Needling' 'Before Care'

- Using an AHA product or other 'peel' for 2 weeks prior to your Skin Needling procedure will help to soften and exfoliate the epidermis which will help make your procedures more effective.
- Receiving a peel or Microdermabrasion from a professional aesthetician prior to each Skin Needling procedure will help your body's natural collagen reproduction.
- If you are planning to receive Botox, make sure that you give yourself at least 2 weeks post your Botox injections before receiving your Skin Needling procedure. You can have Botox injected immediately post Skin Needling if you desire.
- If you are taking a blood thinner, aspirin or any other medication that you have the propensity to bleed easily while on, please tell your technician. If you are under a physician's care and need to discontinue your medication for a few days, always ask your physician prior to each Skin Needling appointment.
- If you bruise easily you may consider taking Arnica Montana pre and post procedure to alleviate bruising and swelling. (Follow manufactures directions)
- The Skin Needling procedure is mostly in the epidermis, however, some discomfort is to be expected.

'Skin Needling' Aftercare

What to Expect: The procedure area will look like red cat scratches for a few days. The deeper we penetrate the epidermis, the redder and longer lasting the scratches will be.

- Your body's own natural collagen in the treatment area will start to plump up and will continue to do so for several weeks/months.
- Some patients see results within the first week, and others may take several weeks to notice discernable results.
- **After Care:** Apply Vaseline or your favorite healing product (with a cotton swab) 2-3 times a day or as needed to keep the area moist for 72 hours following your treatment.
- Cleanse face as you normally would. After Cleaning apply Witch Hazel with a cotton ball. Use your AHA products **after** your face is totally healed.
- Using Collagen or C, or similar 'plumping' products may enhance your 'Skin Needling' results.
- You may apply new mineral makeup after the first day. Use a clean brush and apply to the red areas if needed.
- **Additional Visits:** Visits may be scheduled 4-6 weeks after your initial treatment.

Some patients see results for 12-24 months and request a touch-up at this time, while others may look good for 5+ years. Depending on how you take care of your skin, this will determine the need for any further treatments.

Failure to follow the above advice will result in less than desired results. I agree to follow ALL directions.
